Please note: This newsletter includes billing deadlines for **Summer Session 1 (June 29-August 1)**. Summer Session 2 deadlines will be shared once they become available.

### Student Information Systems Update

- UC San Diego is launching a new student system this summer called the **Triton Student System (TSS)**.
- Summer Session activities (including billing, payments, and registration) will continue in current systems like TritonPay and WebReg.

- Starting mid-July, students will begin accessing Fall 2026 related activities in TSS. More information and guidance will be shared soon.

## WHAT IS COMING UP FOR SUMMER QUARTER?

### Registrar's Office

### Housing Dining Hospitality (a unit of [Residential, Retail and Supply Chain Services](#))

- **Pepper Canyon West - Summer 2026 Housing Billing:** Residents with a Pepper Canyon West 2025-26 twelve-month housing contract are **billed monthly** (on the first of the month) from June to September.
  - Review the [Pepper Canyon West Summer 2026 Billing Schedule](#) for your monthly costs and payment schedule.
  - **If you have a 2026-27 Pepper Canyon West Room Retention housing contract**, please note that you will receive multiple line items billed during the month of September as reflected in the charges below:
    - **September 1-5:** A pro-rated bill representing the last nights of your 2025-26 contract; you are charged the nightly summer rate during this period.
    - **September 7-15:** The start of your 2026-27 PCW Room Retention contract to the start of Fall 2026 quarter billing; you are charged the nightly summer rate during this period.
    - **Fall 2026 Quarterly Bill:** Reflects the total of your Fall Quarter housing and dining charges (if you selected a dining plan).
- **Undergraduate Summer Session Campus Housing: Summer housing is billed monthly for the days of your contract within that month.** As an



example, a Summer Session 1 contract will receive charges in June, July, and August due to the contract spanning those three months.

- **Summer Session 2026 Costs** for summer housing programs are posted on the [Summer Housing website](#).
- Summer Session Housing Billing Schedule 2026:
  - June 1
  - July 1
  - August 5
  - September 1
- **Extended Housing:** Students who apply for and are approved for Extended Housing (current summer 2026 housing resident with a housing contract for 2026-27) will be billed in late September for the additional cost of the Extended Housing program.
- **Summer Session Housing Cancellations and Terminations**
  - If you cancel your summer session housing contract prior to the start date or prior to picking up your keys whichever occurs first, you are assessed a \$150 cancellation fee.
  - If you terminate your summer session housing contract after the start date of the contract or after picking up your keys, you are charged to the end of the week (Saturday) no matter your move out date (if you move out earlier).
- **Graduate & Family Housing:**
  - Rent is billed monthly and visible on TritonPay on the 1st of every month (or the first business day after the 1st if the 1st falls on a holiday or weekend). **TIP!** Set up Autopay via TritonPay to avoid a late rent payment.

- Check your Autopay in TritonPay to ensure that it is set up and will not expire soon!
- Students moving out of Graduate & Family Housing over the summer will see their rate prorated by the first of each month. The amount is calculated to reflect your approved move out date. Please contact your [housing community office](#) if you have questions about your move out charges.

### **Financial Aid and Scholarships**

- Financial Aid funds will be applied toward charges in TritonPay for [eligible students](#) beginning **June 23 for Session 1**. Session 3 aid disbursement dates are based on the start date of your course(s). Any excess financial aid will be automatically refunded to you based on the timeline listed in the Student Financial Solutions section.
- Make sure to [commence academic activity](#) by participating in your classes by the end of week 1 of your summer courses to avoid any adjustments to your federal financial aid.

### **Student Financial Solutions (SFS)**

- Summer Session Triton Registration Installment Plan (TRIP) will be available for Summer Session 1 and Special Session only. Due to the transition to the new Triton Student System (TSS) this August, TRIP will not be offered for Summer Session 2.
- Please note that prior TRIP enrollment does not automatically renew. For this year, TRIP for both Summer Session 1 and Special Session will include two installments. Visit the [How to Pay Your Bill webpage](#) to review Summer Session TRIP deadline dates.
  - **Financial aid disbursement may affect TRIP installment amounts, so we recommend completing your enrollment once all financial aid has been disbursed.**

- Excess financial aid refunds will be processed beginning on **July 1 for Summer Sessions 1 and Special Session.**
  - Paper check arrives within 5-7 business days
    - Important for Fall 2026: Ensure your mailing address is up to date to avoid delays with paper check delivery. You will be asked to check and update your address for Fall 2026.
  - [Enroll](#) in direct deposit to receive your refund faster and avoid potential delays with paper check. Direct deposit to bank account within 2-3 business days.
    - Important for Fall 2026: Direct deposit information will not transfer to the new Triton Student System (TSS). Students will need to set up direct deposit again in TSS before Fall disbursements. Additional instructions will be shared in the Fall.
- Don't forget to authorize new payers in [TritonPay](#).
- Effective July 1, the service fee charged by our credit card payment provider, Transact, will increase from 2.75% to 2.85%. A 3.25% service fee will apply to payments made with international credit cards. - For Fall 2026, undergraduate students living on campus during the 2026–2027 academic year may enroll in monthly housing installments through TritonPay. Enrollment will open after the first housing installment posts in September. Additional details will be emailed to all on-campus residents in August.

### **May**

- May 27 - Registration Fees assess in TritonPay for Session 1 and Special Summer Session

### **June**

- June 1 - Housing fees assesses in TritonPay.
- June 3 - TritonPay monthly eBill statement available.
- June 23 - Session 1 Financial Aid Disbursements.
- June 23 - Registration Fee Payment due for Session 1 and Special Session\* and last date for enrollment in TRIP for Session 1 and Special Session.
- June 23 - Session 1 and 3 Financial aid refunds begin processing.
- June 26- Students with outstanding balances of fees and tuition will be dropped from Summer Session 1 Classes and Special Session.
- June 29 - First day of Session 1 classes.

\*Note: We recommend waiting until the monthly eBills are generated to ensure all relevant charges (including Housing) are on your account before making your payment.

### **July**

- July 1 - Housing fees assesses in TritonPay.

- July 2 - TritonPay monthly eBill statement available.
- July 27 - TRIP due date for Summer Session 1 and Special Session. .

### **August**

- August 3 - Fall [Health Fee Waiver application](#) for academic year 26-27 opens through September 11.
- August 6 - TritonPay monthly eBill statement available.
- August 3 - First day of Session 2 classes.
- August 15 - Monthly billing statement due.
