### WHAT IS COMING UP FOR FALL QUARTER?

## Registrar's Office

- If you're going to be enrolled in 10 units or fewer for Fall 2024, consider [applying for part-time study](#) to be eligible for reduced tuition. The deadline to apply is October 11.
- Remember enrollment for incoming students will run August 12 through August 23, so enrollment for continuing students will be paused during that time.

## Housing Dining Hospitality

### Housing and Dining E-Bill Availability:

- Your housing e-bill will be viewable on September 4, 2024.

### Housing and Dining Payment Options:

- You can choose to pay your housing charges in either monthly or quarterly installments.
- A one-time administrative fee of \$30.00 applies to both payment plans.

### Important Notes for Selecting a Housing Installment Plan:

- Students receiving financial aid should select a quarterly installment plan to ensure that aid is applied to housing charges.
- Housing installment plans are separate from [TRIP \(Triton Registration Installment Plan\)](#), which does not cover housing fees.

### Housing Billing Statement Language:

- Your e-bill and billing statement will display charges as "Fall 2024," regardless of the month or quarter, due to system limitations.

### Cancellation and Termination Policy for Your Housing Contract:

- Students have **until September 20, 2024, 11:59 p.m. (PST)** to cancel their 2024-25 housing contract with no penalty. If you paid your \$450 prepayment, you will receive a full refund. Submit a cancellation request via the [Housing Portal](#).
- Students who no longer wish to live on campus housing **after September 20, 2024, 11:59 p.m. (PST)** must submit a termination request via the [Housing Portal](#). You must meet specific criteria to be approved for a termination. Review your housing contract for termination criteria here: [Housing Contract and Rates](#).

- If you are approved for a termination, you can be charged a minimum of [two weeks of housing and dining charges](#) and will not receive a refund of your \$450 prepayment after September 20, 2024, 11:59PM (PST).

## Dining Information

### Dining Dollars and Triton Cash:

- All Dining Dollars and Triton Cash associated with your dining plan will be uploaded by your move-in date.
- If you are living on campus for the full academic year, you will receive all your Dining Dollar and Triton Cash funds in September. These funds are not distributed based on your housing installment plan.

### Monitoring Your Spending:

- It is important to monitor your spending by frequently checking your Dining and Triton Cash balances via the [Transact eAccounts Portal](#).

### Termination Policy and Your Dining Plan:

- Students who are approved for termination may owe money at move-out if they have spent more Dining Dollars and Triton Cash than they have paid for the academic year.

### Dining Plan Adjustments:

- You have until **October 2, 2024**, to adjust your dining plan selection via the [Housing Portal](#). After this date, adjustments or removals will not be possible.
- Please note that your dining plan is non-refundable and non-transferable.

## Financial Aid and Scholarships Office

- Financial Aid funds will be applied toward charges in TritonPay for [eligible students](#) beginning **September 17**. Any excess financial aid will be automatically refunded to you based on the timeline listed in the Student Financial Solutions section.

- Make sure to [commence academic activity](#) by participating in your classes by the end of week 2 of your fall courses to avoid any adjustments to your federal financial aid.

### **Student Financial Solutions (SFS)**

- The **NEW** TritonPay Office is now open! This centralized location is dedicated to providing in-person support for all student billing, payment, and refund inquiries. It is located at Student Services Center 170 and is open Monday/Tuesday/Wednesday/Friday from 8:30 a.m.-4 p.m., Thursday from 10 a.m.-4 p.m.
- **Need more time to pay your tuition fees?** Enroll in Fall [Triton Registration Installment Plan \(TRIP\)](#) to spread your tuition payments into three monthly installments. Previous TRIP enrollment does not auto-renew.
- Excess financial aid refunds will be processed beginning on September 20.
  - Paper check arrives within 5-7 business days.
  - Enroll in [direct deposit](#) to receive your refund faster and avoid potential delays with paper check. Direct deposit to bank account is within 2-3 business days.
- If you are expecting a parent or another individual to pay your bill, make sure to authorize them in [TritonPay by 9/2/2024 to receive the e-bill email notice for Fall bill](#).
- Go paperless! [E-Consent](#) to get your 2024 1098-T Tax Form electronically.

### **Student Health**

The Student Health Clinic on campus is open for your healthcare needs.

- Thursdays from 9 a.m.-4 p.m., please use MyStudentChart to schedule an appointment.

- The premiums for the Student Health Insurance Plan will be \$898 for undergraduates and \$1881 for graduates per academic quarter.
- If you have health insurance and don't want to pay the registration health fee, please file a timely health fee waiver on the Triton Link. The deadline for this school year is September 14, 2024 for this school year!
