As you prepare for spring quarter, we're back to outline the billing dates and deadlines to be aware of. Please read through this message to learn more about what's coming up this spring.

WHAT IS COMING UP FOR SPRING QUARTER?

Registrar's Office

- Check the Schedule of Classes to see what's offered and your enrollment appointment time, available as of **February 7**.
- Register for upcoming quarter classes beginning **February 15**.
- If you're going to be enrolled in 10 units or fewer, consider [applying for part-time study](#) to be eligible for reduced tuition. The deadline to apply is **April 11**.

Housing Dining Hospitality

- Spring Quarter marks the end of the 2024-25 housing contract (end date is: **June 14** at 3 p.m. or **September 7** at 3 p.m. for Pepper Canyon West).
 - 9-month contract termination requests must be submitted by **May 31**. Billing will be prorated for check out dates that occur not later than May 31.
 - Termination requests are not needed for move out dates between **June 1-14**.
 - Per the housing contract, [the last two weeks of each quarter are not prorated](#) and all students moving out during that time period will be charged through the end of the quarter. As spring quarter is the end of the academic year, your billing will not be prorated if you decide to move out on or after **May 31**.
 - NOTE: Please make sure to follow all check out procedures per your Residential Life Office instructions.
 - **Pepper Canyon West 24-25 contract holders:** May submit termination requests up to **August 25**. You must still meet all housing contract termination criteria as outlined in Section 8.a. Termination by Student. You can find a sample contract [here](#).
- Move out-related damage and administrative charges may be assessed to your student account by your Residential Life Office after performing move out inspections at the end of the academic year. Charges will be assessed to your account no later than **June 30**. If you have charges, you will receive a move out statement via email. You can contact your [Residential Life Office](#) for questions regarding any move out damages.
- **Graduate & Family Housing:** Rent is billed monthly on the first of each month, you can view your bill via TritonPay. **TIP!** Take the thinking out of paying your monthly rent and set up Autopay via TritonPay.

Financial Aid and Scholarships Office

- Financial Aid funds will be applied toward charges in TritonPay for [eligible students](#) beginning **March 22**. Any excess financial aid will be automatically refunded to the student per the timeline listed in the Student Financial Solutions section.

- Make sure to commence academic activity by participating in your classes by the end of week 2 of spring 2025 quarter to avoid any adjustments to your federal financial aid.

Student Financial Solutions (SFS)

- Re-enroll in the [Triton Registration Installment Plan](#) (TRIP) for the upcoming quarter. **Previous TRIP enrollment does not automatically renew.**
- Excess financial aid refunds will be processed beginning on **March 25**.
 - Paper check arrives within 5-7 business days.
 - [Enroll](#) in direct deposit to receive your refund faster and avoid potential delays with paper check
 - Direct deposit to bank account within 2-3 business days
- Don't forget to authorize new payers in [TritonPay](#).

Student Health

- If you missed the Fall health fee waiver deadline or if your insurance coverage has changed since then, you will be able to [apply](#) for the waiver beginning on **February 19**.

UPCOMING DEADLINES

February

- Feb. 15 - Class registration begins
- Feb. 17 - [Health Fee Waiver Application](#) opens
- Feb. 21 - Monthly billing statement due
- Feb. 25 - Registration Fees assess in TritonPay and [TRIP enrollment](#) opens
- Feb. 25 - Estimated Financial Aid Disbursements available in TritonPay

March

- Mar. 5 - Housing fees assess in TritonPay
- Mar. 5 - TritonPay monthly eBill statement available

- Mar. 14 - [Health Fee Waiver Application](#) initial deadline
- Mar. 21 - Registration Fee Payment due*
- Mar. 21 - [Health Fee Waiver Application](#) late waiver deadline
- Mar. 22 - Actual Financial Aid Disbursements begin
- Mar. 25 - Financial aid refunds begin processing
- March 31 - First day of classes/late registration fee payment deadline (to avoid being dropped from classes)

* Note: We recommend waiting until the March eBill is generated on Mar. 5 to ensure all relevant charges (including Housing) are on your account before making your payment.

April

- April 1 - Students with outstanding balances of fees and tuition will be dropped from Spring 2025 classes.
- April 4 - TritonPay monthly eBill statement available.
- April 11 - Deadline to apply for part-time status for reduced tuition and freeze date (deadline for students to add or re-enroll in classes via WebReg).
- April 18 - Monthly billing statement due and last day for late enrollment in TRIP.
