Preparing for summer? Billing for summer differs slightly from the rest of the academic year, so if you'll be continuing your studies through summer quarter, please pay special attention to the dates and deadlines listed below.

WHAT IS COMING UP FOR SUMMER QUARTER?

Registrar's Office

- Registration for Summer Session classes is now open. Check your appointment time in WebReg now!
- Check the Fall 2025 Schedule of Classes to see what's offered and your enrollment appointment time on May 20.
- Register for Fall classes beginning May 23.

Housing Dining Hospitality

- Pepper Canyon West Summer 2025 Housing Billing: Residents with a Pepper Canyon West 2024-25 twelve-month housing contract are billed monthly from June to September.
 - Review the <u>Pepper Canyon West 2024-25 Cost and Payment Schedule</u> for your monthly costs and billing schedule.
 - o If you have a 2025-26 Pepper Canyon West Room Retention housing contract please note that your first Fall 2025 Housing Bill will be assessed by September 2, 2025. You may see both a Summer 2025 September monthly bill and your Fall 2025 Quarterly bill on your estatement.
- Undergraduate Summer Session Campus Housing: Summer housing is billed monthly for the days of your contract within that month. As an example, a Summer Session 1 contract will receive charges in June, July, and August due to the contract spanning those three months.
 - Summer Session 2025 Cost & Payment Schedules for summer housing programs are posted on the <u>Summer Housing website</u> and include total program cost with monthly breakdown.
 - Summer Session Housing Billing Schedule 2025:
 - June 2, 2025
 - July 1, 2025
 - August 5, 2025
 - September 2, 2025
- Extended Housing: Students who apply for and are approved for Extended Housing (current summer 2025 housing resident with a housing contract for 2025-26) will be billed in September for the additional cost of the Extended Housing program.
- Summer Session Housing Cancellations and Terminations

- o If you cancel your summer session housing contract prior to the start date or prior to picking up your keys whichever occurs first, you are assessed a \$150 cancellation fee. If you made your prepayment of \$150 when contracting, the prepayment will not be refunded.
- o If you terminate your summer session housing contract after the start date of the contract or after picking up your keys, you are charged to the end of the week no matter your move out date (if you move out earlier).

Graduate & Family Housing:

- Rent is billed monthly and visible on TritonPay on the 1st of every month (or the first business day after the 1st if the 1st falls on a holiday or weekend). Set up Autopay via TritonPay to avoid a late rent payment.
- Students moving out of Graduate & Family Housing over the summer will see their rate prorated by the 1st of each month. The amount is calculated to reflect your <u>approved</u> move out date. Please contact your <u>housing community office</u> if you have questions about your move out charges.

Financial Aid and Scholarships

- Financial Aid funds will be applied toward charges in TritonPay for <u>eligible</u> <u>students</u> beginning **June 21** for Session 1 and **July 26** for Session 2. Session 3 aid disbursement dates are based on the start date of your course(s). Any excess financial aid will be automatically refunded to you based on the timeline listed in the Student Financial Solutions section.
- Make sure to <u>commence academic activity</u> by participating in your classes by the end of week 1 of your summer courses to avoid any adjustments to your federal financial aid.

Student Financial Solutions (SFS)

- Summer Session <u>Triton Registration Installment Plan (TRIP)</u> will be offered for Summer Session 1, Summer Session 2 and Special Session. <u>Previous TRIP</u> enrollment does not automatically renew.
 - Financial aid disbursement may affect TRIP installment amounts, so we recommend completing your enrollment once all financial aid has been disbursed.
- Excess financial aid refunds will be processed beginning on July 1 for
 Summer Sessions 1 and Special Session, and August 5 for Session 2.
 - Paper check arrives within 5-7 business days
 - Enroll in direct deposit to receive your refund faster and avoid potential delays with paper check
 - Direct deposit to bank account within 2-3 business days
- Don't forget to authorize new payers in TritonPay.
- TritonPay Office revised hours for in-person and phone support effective July
 1:
 - o M-F 10:00am to 4:00pm
- **NEW** Campus Card Office is moving! Pick up your ID cards at the TritonPay Office (Student Services Center 170) beginning on **July 1**.

Student Health

- Student Health Office is open all summer for healthcare needs.
 - Monday, Tuesday, Wednesday and Friday from 8 a.m. to 4p.m.
 - o Thursdays from 9 a.m. to 4 p.m.

May

- May 1 TritonPay monthly eBill available
- May 12 Fall Health Fee Waiver application for AY 25-26 opens on <u>TritonLink</u> through Sept. 14
- May 16 Monthly billing statement due
- May 20 Fall 2025 Schedule of Classes and appointment times released
- May 23 Enrollment begins for Fall 2025
- May 28 <u>TRIP enrollment</u> for Session 1 and Special Session opens- Enrollment begins for Fall 2025

June

- June 4 TritonPay monthly eBill statement available
- June 21 Session 1 Financial Aid Disbursements
- June 23 Registration Fee Payment due for Session 1 and Special Session* and last date for enrollment in TRIP for Session 1.
- June 24 Session 1 and 3 Financial aid refunds begin processing
- June 26- Students with outstanding balances of fees and tuition will be dropped from Special Session

- June 27 Students with outstanding balances of fees and tuition will be dropped from Summer Session 1 classes. TRIP Enrollment for Session 2 opens.
- June 30 First day of Session 1 classes

*Note: We recommend waiting until the monthly eBills are generated to ensure all relevant charges (including Housing) are on your account before making your payment.

July

- July 2 TritonPay monthly eBill statement available
- July 26 Session 2 Financial Aid Disbursements
- July 28 Registration Fee Payment due for Session 2* and last date for enrollment in TRIP for Session 2, Special Session, and MED Summer Session.
- July 30 Session 2 Financial aid refunds begin processing

August

- August 1 Students with outstanding balances of fees and tuition will be dropped from Summer Session 2 classes
- August 2 TritonPay monthly eBill statement available
- August 4 First day of Session 2 classes
- August 22 Monthly billing statement due
